

### **Our Services**

#### **CONNECT 2 KIDS (C2K)**

Trauma-Informed Teacher Consultation that pairs individual teachers with a mental health specialist to help teachers gain insights into the underlying causes of students' disruptive behaviors and to develop trauma-informed approaches.

#### **PARENT SUPPORT**

Extensive guidance and therapy for parents with children in treatment is provided throughout the school year and beyond.

#### BUILDING THE FIELD OF SOCIAL WORK

JPA invests in a highly regarded clinical internship program for graduate-level social workers, with a focus on bringing more social workers of color into the field.

#### **PROFESSIONAL DEVELOPMENT**

Responsive, customized professional development for those working in schools (principals, teachers, school administration and staff), including sessions on self-care, trauma and restorative justice circles.

#### SCHOOL-BASED INDIVIDUAL AND SMALL GROUP THERAPY

JPA therapists see students affected by trauma and toxic stress in their schools, for easy accessibility to treatment. JPA's school-based services consistently see an 89% attendance rate —compared to the less than 15% nationally who receive services and complete treatment.

#### MESIROW CHILD AND FAMILY RESOURCE CENTER

JPA partnered with Children's Place Association, Rush Medical Center, and West Humboldt Park Development Council to create a safe place where families can access trauma-focused mental health therapy, primary care, youth mentoring and community-sponsored activities.

### NEW in FY22

JPA altered our standard offerings due to the increased and evolving demands for our services as a result of the pandemic.



#### SUMMER SERVICES

While our program runs during the school year, many children want to continue to see their therapist over the summer. One of our therapists continued to care for most of her caseload last summer. The one stipulation was that the children had to be enrolled in their school's summer program — a combination of academics and summer camp. The students agreed to participate. This ensured ongoing, consistent mental health support; continued learning eliminating the "summer melt"; and helped keep the kids off the streets during a time when crime is at an all-time high in the city.

#### **HIGH SCHOOL SUPPORT**

For the first time, JPA began to provide individual therapy to students in three high schools. In addition, JPA therapists have also begun offering front-line guidance to students and faculty who need immediate access to a therapist in the form of Drop-In and Crisis Counseling Sessions.





#### **GROUP C2K**

C2K Group Consultation began in response to teachers who have participated in traditional C2K in the past and have benefited from the learnings of the program, but still want to be able to discuss specific concerns with a C2K Consultant. These teachers periodically meet with a C2K Consultant as a group to discuss issues that are affecting their classrooms, individual students and their school as a whole.

### FY22 Therapy Impact

- 94% of teachers reported that JPA had a positive impact on their school's environment

**78%** of children receiving JPA therapy saw positive improvements in their mood

94% of teachers reported that their interactions with students who received JPA's individual counseling improved

### C2K Impact on Teachers

**89%** reported C2K had a positive impact on classroom environment

**89%** indicated C2K helped them better understand/respond to students' challenging behaviors

**84%** indicated C2K helped them better understand the social/emotional needs of students

82% indicated their relationships with students discussed in consultation improved

95% reported feeling listened to and supported during C2K consultation

# Addressing the Need

In December 2021, the Surgeon General issued an advisory highlighting the urgent need to address the youth mental health crisis as a result of the unprecedented negative impacts of COVID-19.

Those identified by the Surgeon General as having a higher risk of mental health challenges during the pandemic – racial and ethnic minority youth, low-income youth, and youth in special populations (homeless and those involved in the juvenile justice and/or child welfare systems) – are the same populations served by JPA.

JPA's programs are perfectly aligned with the Surgeon General's recommendations for improving youth mental health. Through the support and generosity of our partners, JPA was able to expand to offer high-quality mental health care to even more of the children, caregivers and educators who needed us most.




